A BILL

To modify and extend the temporary reduction of duty on Isoxaflutole.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. ISOXAFLUTOLE.
4	(a) In General.—Heading 9902.11.46 of the Har-
5	monized Tariff Schedule of the United States (relating to
6	Isoxaflutole) is amended—
7	(1) by striking "Free" and inserting "4.6%";
8	and
9	(2) by striking "12/31/2012" and inserting

"12/31/2015".

- 1 (b) Effective Date.—The amendments made by
- 2 subsection (a) apply with respect to goods entered, or
- 3 withdrawn from warehouse for consumption, on or after

4 the 15th day after the date of enactment of this Act.
