1 Be it enacted by the Senate and House of Representa-

3 SECTION 1. ESTERS AND SODIUM ESTERS OF 4 PARAHYDROXYBENZOIC ACID.

5 (a) IN GENERAL.—Heading 9902.02.75 of the Har-6 monized Tariff Schedule of the United States (relating to 7 esters and sodium esters of parahydroxybenzoic acid) is 8 amended by striking the date in the effective period col-9 umn and inserting "12/31/2015". (b) EFFECTIVE DATE.—The amendment made by
this section applies to goods entered, or withdrawn from
warehouse for consumption, on or after the 15th day after
the date of the enactment of this Act.
