To suspend temporarily the duty on Ammonium polyacryloyldimethyl taurate.

1	Be it enacted by the Senate and House of Representa-

3	SECTION 1. AMMONIUM POLYACRYLOYLDIMETHYL

5	(a) In General.—Subchapter II of chapter 99 of
