To extend the suspension of duty on certain ethylene-vinyl acetate copolymers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. CERTAIN ETHYLENE-VINYL ACETATE COPOLY-
- 4 MERS.
- 5 (a) IN GENERAL.—Heading 9902.24.55 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 certain ethylene-vinyl acetate copolymers) is amended by
- 8 striking the date in the effective period column and insert-
- 9 ing "12/31/2015".
- 10 (b) Effective Date.—The amendment made by
- 11 this section applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
