#### **3** SECTION 1. DELTAMETHRIN.

4 (a) IN GENERAL.—Heading 9902.11.26 of the Har5 monized Tariff Schedule of the United States (relating to
6 Deltamethrin) is amended by striking "12/31/2009" and
7 inserting "12/31/2015".

8 (b) EFFECTIVE DATE.—The amendments made by 9 subsection (a) apply with respect to goods entered, or 10 withdrawn from warehouse for consumption, on or after 11 the 15th day after the date of enactment of this Act.
