Mr. Cleaver introduced the following bill; which was referred to the Committee on Ways and Means

A BILL

To modify and extend the temporary reduction of duty on \mathfrak{B}\-eyfluthrin.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. B-CYFLUTHRIN.

(a) IN GENERAL.—Heading 9902.02.64 of the Harmonized Tariff Schedule of the United States (relating to B-cyfluthrin) is amended—

(1) by striking "4.8%" and inserting "2.1%";

and

(2) by striking "12/31/2012" and inserting

"12/31/2015".

- 1 (b) Effective Date.—The amendments made by
- 2 subsection (a) apply with respect to goods entered, or
- 3 withdrawn from warehouse for consumption, on or after

4 the 15th day after the date of enactment of this Act.
