Some of the trifloxystrobin imported by the interested entity is converted to the formulated product addressed in this legislation in a U.S. Foreign Trade Zone.

The modified article description reflects: (1) a change in the chemical nomenclature for trifloxystrobin (one of the components for the mixture) to align it with the nomenclature used in the existing chapter 99 provision for trifloxystrobin; (2) editorial changes; (3) a statement by the interested entity that the HTS subheading listed in the legislation as introduced (3808.91.50) should be changed to 3808.92.15; and (4) after speaking with the appropriate National Import Specialist at U.S. Customs and Border Patrol, replacing ", including" with "and" to make the description consistent with the other mixtures of heading 3808 in chapter 99.
