II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures containing N-[2-[3-chloro-5-(trifluoromethyl)-2-pyridyl]ethyl]- α , α , α -trifluoro-ortho-toluamide (Fluopyram) (CAS No. 658066–35–4) and methyl (E)-methoxyimino-{(E)- α -[1-(α , α , α -trifluoro-m-tolyl)ethylideneaminooxy]-o-tolyl}acetate (Trifloxystrobin) (CAS No. 141517–21–7) and application adjuvants (provided for in subheading 3808.92.15)

III. Other product information, including uses/applications and source(s) of imports

The subject product is a formulated fungicide that provides a systemic solution for protection against powdery mildew, cherry leaf spot, brown rot blossom blight, ruit rot, and various post-harvest rots. The fluopyram is sourced from Germany and the trifloxystrobin is sourced from Switzerland. The formulated product is produced in a U.S. Foreign Trade Zone using the foreign-sourced active ingredients.

V. Technical comments

The modified article description reflects: (1) the corrected IUPAC nomenclature for fluopyram versus that presented in the bill; (2) a change in the chemical nomenclature for trifloxystrobin to that used in the Chapter 99 provision for trifloxystrobin; (3) replacement of ", including" with "and" to align the provision with the format used in Chapter 38 for mixtures; and (4) the corrected HTS subheading (noted by the interested entity) for the formulated fungicide mixtures.
