To suspend temporarily the duty on Fenhexamid.

1	Be it enacted by the Senate and House of Representa-									
2	tives of the United States of America in Congress assembled,									
3	SECTION 1. FENHEXAMID.									
4	(a) In General.—Subchapter II of chapter 99 of									
5	the Harmonized Tariff Schedule of the United States is									
6	amended by inserting in numerical sequence the following									
7	new heading:									
	"	9902.01.00	N-(2,3-Dichloro-4-hydroxyphenyl)-1-methylcyclohexanecarboxamide (Fenhexamid) (CAS No. 126833–17–8) (provided for in subheading 2924.29.47)	Free	No change	No change	On or before 12/31/2015	".
