#### II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Formulations containing (R)-α-cyano-3-phenoxybenzyl (1S,3S)-3-(2,2-dichlorovinyl)-2,2-dimethylcyclopropanecarboxylate (Alpha-cypermethrin) (CAS No. 67375–30–8) and application adjuvants (provided for in subheading 3808.91.25)

(If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.)

III. Other product information, including uses/applications and source(s) of imports

The subject product is an insecticide used to control a wide range of chewing and sucking insects in certain crops; to control cockroaches, mosquitoes, flies, and other insect pests in public health; and to control flies in animal houses. The product is imported from India, Germany, and France.
