II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Mixtures of (E)-1-(2-chloro-1,3-thiazol-5-ylmethyl)-3-methyl-2-nitroguanidine (Clothianidin) (CAS No. 210880–92–5) and Bacillus Firmus (B. firmus I-1582) and application adjuvants (provided for in subheading 3808.91.50)

III. Other product information, including uses/applications and source(s) of imports

The subject product is a seed treatment for corn, soybean, and cotton that protects early season seedlings and roots from numerous insect and nematode pests. The interested entity states that the active ingredients--Clothianidin and Bacillus Firmus--are sourced from Germany and Mexico, respectively, and formulated into the subject product in a U.S. Foreign Trade Zone. The subject product is then entered into the United States under the specified HTS subheading.

The modified article description reflects use of the chemical nomenclature (IUPAC) for Clothianidin that appears in the Chapter 99 provision addressing imports of the technical product in Chapter 29. In addition to minor edits, the wording has also been changed to better align it with wording used in other Chapter 99 provisions for mixtures.
