A BILL

To extend the suspension of duty on product mixtures containing ethofumesate.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. PRODUCT MIXTURES CONTAINING 4 ETHOFUMESATE.

(a) IN GENERAL.—Heading 9902.05.19 of the Harmonized Tariff Schedule of the United States (relating to
product mixtures containing ethofumesate) is amended by
striking the date in the effective period column and inserting "12/31/2015".

(b) EFFECTIVE DATE.—The amendment made by
 subsection (a) applies to goods entered, or withdrawn from
 warehouse for consumption, on or after the 15th day after
 the date of the enactment of this Act.
