## A BILL

To suspend temporarily the duty on cyprosulfamide.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. CYPROSULFAMIDE.
4	(a) In General.—Subchapter II of chapter 99 of
5	the Harmonized Tariff Schedule of the United States is
6	amended by inserting in numerical sequence the following
7	new heading:
	" 9902.01.00 Cyprosulfamide: N-({4- [(Cyclopropylamino) ear- bonyl]phenyl}sulfonyl)-2-

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
