A BILL

To extend the temporary suspension of duty on 1,2,4-Trichlorobenzene.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. 1,2,4-TRICHLOROBENZENE.
- 4 (a) In General.—Heading 9902.22.33 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 1,2,4-Trichlorobenzene) is amended by striking the date
- 7 in the effective period column and inserting "12/31/2015".
- 8 (b) Effective Date.—The amendments made by
- 9 subsection (a) apply to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
