A BILL

To suspend temporarily the duty on 1,3-Benzenedicarbonitrile.

1	Be it enacted by the Senate and House of Representa-
2	$tives\ of\ the\ United\ States\ of\ America\ in\ Congress\ assembled,$
3	SECTION 1. 1,3-BENZENEDICARBONITRILE.
4	(a) In General.—Heading 9902.12.06 of the Har-
5	monized Tariff Schedule of the United States (relating to
6	1,3-Benzenedicarbonitrile) is amended—
7	(1) by striking "3.4%" and inserting "Free";
8	and
9	(2) by striking the date in the effective period
10	column and inserting "12/31/2015".

- 1 (b) Effective Date.—The amendments made by
- 2 subsection (a) apply with respect to goods entered, or
- 3 withdrawn from warehouse for consumption, on or after

4 the 15th day after the date of enactment of this Act.
