The synthetic organic chemical is used to make fungicides for foliar and seed disease control in a broad range of crops. It is imported from Switzerland.

In addition to extending the temporary reduction of duty, this bill would also change the rate of duty of the existing Chapter 99 provision from 1 percent to 5.7 percent.

**3** SECTION 1. FLUDIOXONIL.

4 (a) IN GENERAL.—Heading 9902.12.54 of the Har5 monized Tariff Schedule of the United States (relating to
6 fludioxonil) is amended—

7 (1) by striking "1.0%" and inserting "5.7%";
8 and

9 (2) by striking the date in the effective period
10 column and inserting "12/31/2015".

(b) EFFECTIVE DATE.—The amendments made by
 subsection (a) apply with respect to goods entered, or
 withdrawn from warehouse for consumption, on or after
 the 15th day after the date of enactment of this Act.
