To extend and modify the temporary reduction of duty on Oxadiazon.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. OXADIAZON.

4 (a) IN GENERAL.—Heading 9902.10.73 of the Har5 monized Tariff Schedule of the United States (relating to
6 Oxadiazon) is amended—

7 (1) by striking "0.9%" and inserting "0.6%";
8 and

9 (2) by striking the date in the effective period
10 column and inserting "12/31/2015".

(b) EFFECTIVE DATE.—The amendments made by
 subsection (a) apply to goods entered, or withdrawn from
 warehouse for consumption, on or after the 15th day after
 the date of the enactment of this Act.
