## III. Other product information, including uses/applications and source(s) of imports

The subject synthetic organic chemical is a fungicide applied to citrus fruits, apples, and pears to prevent fungal decay and spoilage in storage. It is imported from Germany.

Although the bill is written as a new duty suspension, Chapter 99 provision 9902.24.85, which expired on December 31, 2009, covered the subject product.
