## A BILL

To extend the suspension of duty on Paraquat dichloride (1,1'-dimethyl-4,4'-bipyridinium dichloride).

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PARAQUAT DICHLORIDE (1,1'-DIMETHYL-4,4'-
- 4 BIPYRIDINIUM DICHLORIDE).
- 5 (a) In General.—Heading 9902.13.06 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 Paraquat dichloride (1,1'-dimethyl-4,4'-bipyridinium di-
- 8 chloride)) is amended by striking the date in the effective
- 9 period column and inserting "12/31/2015".

- 1 (b) Effective Date.—The amendment made by
- 2 this section applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
