- 3 SECTION 1. 4,8-DICYCLOHEXYL -6-2,10-DIMETHYL -12H-
- 4 DIBENZO[D,G][1,3,2]- DIOXAPHOSPHOCIN.
- 5 (a) In General.—Heading 9902.12.77 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 4,8-Dicyclohexyl -6-2,10-dimethyl -12H-
- 8 dibenzo[d,g][1,3,2]- dioxaphosphocin) is amended by
- 9 striking the date in the effective period column and insert-
- 10 ing "12/31/2015".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
