A BILL

To extend the temporary suspension of duty on mixtures of NN-(3,4-dichloro-phenyl)-N,Ndimethylurea with acrylate rubber.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. MIXTURES OF NN-(3,4-DICHLORO-PHENYL)-
- 4 N,NDIMETHYLUREA WITH ACRYLATE RUB-
- 5 BER.
- 6 (a) IN GENERAL.—Heading 9902.12.75 of the Har-
- 7 monized Tariff Schedule of the United States (relating to
- 8 mixtures of NN-(3,4-dichloro-phenyl)-N,Ndimethylurea
- 9 with acrylate rubber) is amended by striking the date in
- 10 the effective period column and inserting "12/31/2015".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
