2-Oxepanone, polymer with aziridine and tetrahydro-2H-pyran-2-one, dodecanoate ester (CAS No. 202263-77-2 ) in bulk or 40% by weight solution in n-butyl acetate (provided for in subheadings 3208.10.00 and 3907.99.01)

### III. Other product information, including uses/applications and source(s) of imports

The polymer improves dispersion and stability in UV cured coatings. In solution, the product disperses organic and inorganic pigments into solvent-based industrial paints. The product is imported from the United Kingdom.

In addition to renewing the temporary duty suspension for the polymer which expired in 2009, this bill would also modify the existing Chapter 99 provision by adding the CAS number for the product.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 2 3 SECTION 1. 2-OXEPANONE, POLYMER WITH AZIRIDINE AND 4 **TETRAHYDRO-**2H-PYRAN-2-ONE, 5 **DODECANOATE ESTER.** 6 (a) IN GENERAL.—Heading 9902.03.24 of the Harmonized Tariff Schedule of the United States (relating to 7 8 2-Oxepanone, polymer with aziridine and tetrahydro- 2H-9 pyran-2-one, dodecanoate ester) is amended1 (1) by inserting "(CAS No. 202263–77–2)" 2 after "ester"; and

3 (2) by striking the date in the effective period
4 column and inserting "12/31/2015".

5 (b) EFFECTIVE DATE.—The amendment made by
6 subsection (a) applies to goods entered, or withdrawn from
7 warehouse for consumption, on or after the 15th day after
8 the date of the enactment of this Act.
