#### II. Suggested article description(s) for enactment (including appropriate HTS subheading(s)):

Cassia hydroxypropyltrimonium chloride (D-Galacto-D-mannan, 2-hydroxy-3-(trimethylammonio)propylether, chloride) (CAS No. 83589–59–7), 1-Propanaminium, 2,3-dihydroxy-N,N,N-trimethyl-, chloride (CAS No. 34004–36–9) and water (provided for in subheading 1302.39.00)

(If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.)

#### III. Other product information, including uses/applications and source(s) of imports

The subject product is a cationic derivative of cassia gum. Cassia gum is derived from the seeds of cassia tora/cassia obtusifolia. This product is also known by the trade name of Sensomer CT-400 Polymer. It is a light tan or yellowish powder and has a fruity odor, and is used as a thickening/stabilization agent for personal care products such as shampoos, hair conditioners, body washes, and facial cleansers. It is imported from India under HTS subheading 1302.39.00, which is a basket category for mucilages and thickeners, whether or not modified, derived from vegetable products.
