- 4 (a) In General.—Heading 9902.25.33 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 2-Amino-5,8-dimethoxy-(1,2,4)triazolo(1,5-c)pyrimidine)
- 7 is amended by striking the date in the effective period col-
- 8 umn and inserting "12/31/2015".
- 9 (b) Effective Date.—The amendment made by
- 10 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
