3 SECTION 1. QUINTEC.

4 (a) IN GENERAL.—Heading 9902.25.38 of the Harmonized Tariff Schedule of the United States (relating to 5 of 6 mixture quinoxyfen (5,7-dichloro-4-(4-7 fluorophenoxyquinoline)) and application adjuvants) is 8 amended by striking the date in the effective period column and inserting "12/31/2015". 9

10 (b) EFFECTIVE DATE.—The amendment made by11 subsection (a) applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- $2 \ \ {\rm the \ date \ of \ the \ enactment \ of \ this \ Act.}$
