2	tives of the United States of America in Congress assembled,
3	SECTION 1. MIXTURES OF CYMOXANIL AND INERT INGRE-
4	DIENTS.
5	(a) In General.—Subchapter II of chapter 99 of
6	the Harmonized Tariff Schedule of the United States is
7	amended by inserting in numerical sequence the following
8	new heading:
	" 9902.01.00 Mixtures of cymoxanil (CAS No. 57966–95–7) and inert ingredients (provided for in subheading 3808.92.50) Free No change No change On or before 12/31/2015 ".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
