### A BILL

To extend the suspension of duty on Acetoacetyl-2,5-dimethoxy-4-chloroanilide.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ACETOACETYL-2,5-DIMETHOXY-4-
- 4 CHLOROANILIDE.
- 5 (a) In General.—Heading 9902.23.64 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 Acetoacetyl-2,5-dimethoxy-4-chloroanilide) is amended by
- 8 striking the date in the effective period column and insert-
- 9 ing "12/31/2015".

- 1 (b) Effective Date.—The amendment made by
- 2 this section applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
