### A BILL

To extend the suspension of duty on 3-Amino-4-methylbenzamide.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. 3-AMINO-4-METHYLBENZAMIDE.
- 4 (a) In General.—Heading 9902.23.63 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 3-Amino-4-methylbenzamide) is amended by striking the
- 7 date in the effective period column and inserting "12/31/
- 8 2015".
- 9 (b) Effective Date.—The amendment made by
- 10 this section applies to goods entered, or withdrawn from

- 1 warehouse for consumption, on or after the 15th day after
- 2 the date of the enactment of this Act.
