## A BILL

To extend the suspension of duty on 5-Chloro-3-hydroxy-2-methoxy-2-naphthanilide.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. 5-CHLORO-3-HYDROXY-2-METHOXY-2-
- 4 NAPHTHANILIDE.
- 5 (a) In General.—Heading 9902.23.58 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 5-Chloro-3-hydroxy-2-methoxy-2-naphthanilide) is amend-
- 8 ed by striking the date in the effective period column and
- 9 inserting "12/31/2015".

- 1 (b) Effective Date.—The amendment made by
- 2 this section applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
