To suspend temporarily the rate of duty on 4-Bromobenzyl Bromide.

3	SECTION 1. 4-BROMOBENZYL BROMIDE.						
4	(a) In General.—Subchapter II of chapter 99 of						
5	the Harmonized Tariff Schedule of the United States is						
6	amended by inserting in numerical sequence the following						
7	new heading:

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to articles entered, or withdrawn
- 3 from warehouse for consumption, on or after the 15th day

4 after the date of the enactment of this Act.
