To suspend temporarily the rate of duty on alpha-Phenyl-2-piperidylacetic acid.

1	Be it enacted by the Senate and House of Representa-

3	SECTION 1. ALPHA-PHENYL-2-PIPERIDYLACETIC ACID.					
4	(a) In General.—Subchapter II of chapter 99 of					
5	the Harmonized Tariff Schedule of the United States is					
6	amended by inserting in numerical sequence the following					
7	new heading:					
	" 9902.01.00 alpha-Phenyl-2- piperidylacetic acid (CAS No. 19395-41-6) (pro- vided for in subheading 2933.39.91)					

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to articles entered, or withdrawn
- 3 from warehouse for consumption, on or after the 15th day

4 after the date of the enactment of this Act.
