Re: Opposition to H.R. 5106 and S. 2796

To Whom It May Concern:

On behalf of Lonza, I am writing to oppose H.R. 5106 and S. 2796, which would suspend temporarily the import duty on hydrazine hydrate, aqueous solution. Lonza (formerly Arch Chemicals) is the only U.S. producer of hydrazine hydrate, and hydrazine propellants at our Lake Charles, Louisiana production facility. As such, Lonza objects to the proposed tariff change.

My understanding is that these bills would allow imports of hydrazine hydrate to enter the U.S. at a zero percent duty compared with the current 3.7% duty. This would allow imports of hydrazine hydrate to enter from countries which have a combination of lower production costs and higher import duties on hydrazine products produced in the U.S. These bills would negatively affect our ability to competitively produce hydrazine hydrate in the U.S. and supply it to the domestic and international markets. Most notably, in 2004 China imposed a duty of 184% on imports of U.S. produced hydrazine. The duty remains in effect today. This effectively takes away Lonza's ability to compete in the growing Chinese market. If the duty is abolished it will allow Japanese, Germans and French-based companies to import to the U.S. without duty while U.S. exports will continue to pay duty of approximately 5% to these countries.

In 2005, Lonza (formerly Arch Chemicals) was awarded a 20-year contract by the United States Department of Defense for the production, storage, distribution and handling of hydrazine propellants for the U.S. government from our Lake Charles, Louisiana production facility. The terms of the contract call for an initial 10-year supply contract which began in 2005, followed by two five-year renewal terms at the option of the government. For more than 50 years, Lonza has served as the sole U.S. supplier of hydrazine propellants.

Additionally, Lonza (formerly Arch Chemicals) has previously objected to a similar hydrazine tariff suspension request in 2005 and 2008.

## A BILL

To suspend temporarily the duty on hydrazine hydrate, aqueous solution.

1	Be it enacted by the Senate and House of Representa-

4	(a) In General.—Subchapter II of chapter 99 of

	" 9902.01.00 Hydrazine hydrate, aqueous solution (all grades) (CAS No. 7803–57–8) (provided for in subheading 2825.10.00) Free No change No change On or before 12/31/2015 ".
