- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. 1,3-BENZENEDICARBOXAMIDE, N, N'-BIS-(2,2,6,6-
- 4 TETRAMETHYL-4-PIPERIDINYL)-.
- 5 (a) In General.—Heading 9902.04.11 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 1,3-Benzenedicarboxamide, N, N'-bis-(2,2,6,6-
- 8 tetramethyl-4-piperidinyl)-) is amended by striking the
- 9 date in the effective period column and inserting "12/31/
- 10 2015".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
