A BILL

To extend and modify the temporary suspension of duty on Desmodur HL BA.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. DESMODUR HL BA.
- 4 (a) In General.—Heading 9902.12.18 of the Har-
- 5 monized Tariff Schedule of the United States (relating to
- 6 Desmodur HL BA) is amended—
- 7 (1) by amending the article description to read
- 8 as follows: "2,4-Diisocyanato-1-methylbenzene, poly-
- 9 mer with 1,6-diisocyanatohexane (CAS No. 26426–

- 1 91–5) dissolved in organic solvent (provided for in 2 subheading 3911.90.45)"; and
- 3 (2) by striking the date in the effective period
- 4 column and inserting "12/31/2015".
- 5 (b) Effective Date.—The amendment made by
- 6 subsection (a) applies to goods entered, or withdrawn from
- 7 warehouse for consumption, on or after the 15th day after
- 8 the date of the enactment of this Act.
