Poly(oxy-1,2-ethandiyl), α -[(2Z)-3-carboxy-1-oxo-2-propenyl]-ω-hydroxy-, C9-11-alkyl ethers (CAS 709014-50-6); fatty acids, tall oil, reaction products with polyethylene polyamines (CAS No. 68910-93-0); maleic acid (CAS No.110-16-7); and 3,6,9,12-tetraazatetradecane-1,14-diamine (CAS No. 4067-16-7) (provided for in subheading 3402.90.50)

The subject product is a dispersing and wetting agent used in the formulation of volatile organic compound (VOC)-free universal colorant systems. It is imported from the Netherlands.
