### A BILL

To reduce temporarily the duty on fasteners, in clips suitable for use in a mechanical attaching device.

1	Be it enacted by the Senate and House of Representa-						
2	tives of the United States of America in Congress assembled,						
3	SECTION 1. FASTENERS, IN CLIPS SUITABLE FOR USE IN A						
4	MECHANICAL ATTACHING DEVICE.						
5	(a) In General.—Subchapter II of chapter 99 of						
6	the Harmonized Tariff Schedule of the United States is						
7	amended by inserting in numerical sequence the following						
8	new heading:						
	" 9902.01.00 Fasteners, in clips suitable for use in a mechanical attaching device (provided for in subheading 3926.90.85)						

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to goods entered, or withdrawn from
- 3 warehouse for consumption, on or after the 15th day after

4 the date of the enactment of this Act.
