RE: Polyterpene Temporary Duty Suspension

Dear Ms. Nesbitt:

Attached is the AZC rebuttal of the Eastman Chemical Company proposal, HR 5298, sponsored by Representative David Roe of Tennessee.

- Arizona Chemical is a domestic producer of polyterpenes (CAS number 70750-57-1, Harmonized Tariff Code 3911.10.000) which compete with imported petroleum resin (9902.01.00 Petroleum resins, coumarone, indene or coumarone-indene resins; polyterpenes). Accordingly, we object to a duty suspension for petroleum resins. The duty suspension will likely serve to increase trade imbalances, as AZC polyterpenes compete with imported products on small margin differences.
- Arizona Chemical produces over 15,000 short tons of competitive product domestically, primarily
 utilizing US biomass materials. As a producer of bio-based chemicals which does not receive bioenergy subsidies, we believe that additional assistance to our competitors is not warranted.
- There is no known benefit to Arizona Chemical if the duty suspension is granted. To the contrary, we believe that it would damage Arizona Chemical, who manufactures competitive product in Florida.
- Arizona Chemical has no formal affiliation with Eastman Chemical Company, though we are both members of the Pine Chemical Association and operate chemical businesses in the US.

A BILL

To suspend temporarily the duty on petroleum resins, coumarone, indene or coumarone-indene resins; polyterpenes.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, 3 SECTION 1. PETROLEUM RESINS, COUMARONE, INDENE OR 4 **COUMARONE-INDENE RESINS:** 5 POLYTERPENES. 6 (a) IN GENERAL.—Subchapter II of chapter 99 of the Harmonized Tariff Schedule of the United States is 7 8 amended by inserting in numerical sequence the following new heading:
