The subject product includes girls' casual shoes, with outer soles of leather, composition leather, rubber or plastics and uppers of leather. Such footwear is imported under the residual or "basket" statistical reporting number 6403.99.9071. China is the leading supplier of imports of this footwear, followed by Vietnam and Indonesia.
