To reduce temporarily the rate of duty on Boscalid.

1	Be it enacted by the Senate and House of Representa-									
2	tives of the United States of America in Congress assembled,									
3	SECTION 1. BOSCALID.									
4	(a) In General.—Subchapter II of chapter 99 of									
5	the Harmonized Tariff Schedule of the United States is									
6	amended by inserting in numerical sequence the following
