## A BILL

To suspend temporarily the rate of duty on Dichloroacetyl Chloride.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. DICHLOROACETYL CHLORIDE.
4	(a) In General.—Subchapter II of chapter 99 of
5	the Harmonized Tariff Schedule of the United States is
6	amended by inserting in numerical sequence the following
7	new heading:
	" 9902.01.00 2,2-dichloroacetyl chloride (CAS No. 79–36–7) (provided for in HTS subheading 2915.40.50) Free No change No change On or before 12/31/2015 ".

- 1 (b) Effective Date.—The amendment made by
- 2 subsection (a) applies to articles entered, or withdrawn
- 3 from warehouse for consumption, on or after the 15th day

4 after the date of the enactment of this Act.
