FSIS Provides Overview for Nutrition Labeling and Posts Q&As on AskFSIS

The agency recently announced the publication of the final rule on *Nutrition Labeling of Single-Ingredient Products and Ground or Chopped Meat and Poultry Products*, (www.gpo.gov/fdsys/pkg/FR-2010-12-29/pdf/2010-32485.pdf).

The final rule requires nutrition information for the major cuts of single-ingredient, raw meat and poultry products on the label or at point-of-purchase, unless an exemption applies. The rule also requires nutrition information for all ground or chopped products on the label of the products, unless an exemption applies. In addition, it permits the labels of these products to include a lean percentage statement as long as a fat percentage statement also is displayed on the label.
