Update on Industry Access to PHIS

FSIS Administrator Al Almanza announced on Tuesday that industry access to PHIS would be postponed as a result of the agency's current budget situation. "The move," he said, "would not affect agency implementation of PHIS."

"We did not make this decision lightly," Almanza said. "We knew that we had all of the funding in place to fully implement PHIS within the agency, but we would not have been able to support real-time questions that the industry may have had. Rather than providing access without proper support, we decided to postpone this part of PHIS until we have the funding in place. This is disappointing, but it is the right thing to do."

Under the original plan, establishments would have been immediately given an "invitational key" to interact electronically with FSIS and perform a wide variety of tasks, including submitting export applications and other information, scheduling incoming shipments, reading reports and responding to and appealing noncompliance records. Until establishments have access to PHIS, they will continue to receive information and updates from inspection personnel.

PHIS is expected to be launched the second week in April, and will be implemented in sequential stages. For more information about PHIS, visit www.fsis.usda.gov/phis/.

FSIS Restructures CID Regions

Inspection Seminars Designed for International Government Officials

FSIS will host a meat and poultry inspection seminar for international officials in Mayaguez, PR, from May 16 through June 11.

This seminar will be held in cooperation with the University of Puerto Rico and includes basic HACCP certification. There will also be an in-depth review of FSIS verification of HACCP and sanitation requirements.

Other topics and activities include import and export policies and procedures, foreign inspection program equivalence, and field visits. This seminar will be conducted in Spanish.

NACMCF Subcommittee to Hold Public Meeting

A subcommittee of the National Advisory Committee on Microbiological Criteria for Foods (NACMCF) will hold public meetings from April 5-7.

NACMCF's subcommittee on the Study of Microbiological Criteria as Indicators of Process Control or Insanitary Conditions is meeting to develop guidance to assist the Department of Defense (DoD). DoD will use this guidance in developing refined microbiological and other criteria to better evaluate process control and insanitary conditions at the point of production.

The meetings will take place on Tuesday, April 5, from 11:00 a.m. to 5:00 p.m.; Wednesday, April 6, from 8:30 a.m. to 5:00 p.m.; and Thursday, April 7, from 8:30 a.m. to noon at the Aerospace Building, 901 D St., SW, Room 369, Washington, DC.
