

2011 Budget Request

- February 1, 2010, President Obama released his Fiscal Year 2011 budget request of \$1.416 b for the Corporation (23.1% increase)
 - AmeriCorps State & National: \$488.033m(31% increase)
 - Commission Administrative: \$ 18.0m
 - Commission PDAT: \$ 6.6m
 - Commission Disability: \$ 4.5m
 - Serve America Fellowships \$ 1.0m

AmeriCorps 2010 Grant Process

- New Funding Priorities
 - National Performance Measures Pilot
- Combined Competition
- Full-time Fixed Amount Grant Pilot

2010 Funding Priorities

- Education Especially helping children and youth achieve success in school and prevent them from dropping out before high school graduation
- Health Including access to health care, health literacy, and disease prevention and health promotion initiatives
- Clean Energy/Environment Energy-efficiency and environmental needs within communities

2010 Funding Priorities (cont.)

- Veterans Engaging veterans in service, as well as addressing the needs of veterans, members of the Armed Forces who are on active duty, and family members of deployed military personnel
- Economic Opportunity Including financial literacy, housing assistance, job training, and nutritional assistance

2010 Funding Priorities (cont.)

- National Performance Measures allow for aggregated reporting of the impact of AmeriCorps
- New Applicants applicants that haven't received an operational grant in the last 5 years
- Encore Programs include a significant number of participants age 55 or older and take advantage of the skills and experience that such participants offer

Combined Competition

- The State Competitive and National Direct grant competitions are combined into one
- Multi-state applicants are required to consult with state commissions prior to grant submission, and describe that consultation in their application
- The Corporation will solicit and consider the views of State Commissions on programs proposing to operate in their states

Key Serve America Act (SAA) Changes in Effect

- Education Award Increase
- Criminal History Check Requirement Changes
- New Tutoring Requirement
- New Prohibited Member Activity
- New Prohibited Grant Activity

Education Award

- The Education Award will be tied in value to the Pell Grant beginning with <u>AmeriCorps members</u> <u>serving in programs funded out of 2010</u> <u>appropriations</u>
- For AmeriCorps State and National, this impacts members serving in programs that will be funded through the competition that takes place next year

Education Award (cont.)

- The Education Award <u>has not</u> increased for currently serving AmeriCorps State and National members
- The Education Award <u>has</u> increased for VISTA and NCCC members who began service after October 1, 2009

Criminal History Check Requirement Changes

- Programs must perform criminal background checks on all members enrolled on or after 10/01/2009 – regardless of whether they have recurring access to vulnerable populations
- Effective 10/01/2009, individuals convicted of murder are ineligible to serve

New Tutoring Requirement

 Effective 10/01/2009, members serving as tutors must have a high school diploma

New Prohibited Member Activity

- Beginning 10/01/2009, members may not provide abortion services or make referrals for such services
- This includes members who enrolled prior to 10/01/2009

New Prohibited Grant Activity

 Grant funds cannot be used for the <u>sole</u> purpose of referring individuals for other Federal assistance or State assistance programs funded in part by the Federal Government.

Key SAA Changes Not Yet in Effect

- On February 23, 2010, a Notice of Proposed Rulemaking was issued to implement changes to the operation of the National Service Trust under the Serve America Act, including:
 - Maximum number of terms of service
 - Transferability of the Education Award

Key SAA Changes Not Yet in Effect (cont.)

- Until this rulemaking is complete, all current rules on term limitations remain in place.
 - http://www.nationalservice.gov/about/ serveamerica/rulemaking.asp
 - Proposed Rule; Information on how to provide comment; Conference call information
- During this Rulemaking process, Corporation staff cannot engage in discussions about the content of the proposed Rule

Ensuring Compliance

- Ask questions in the appropriate sessions here
- Review your internal procedures, member contracts, etc. to ensure that you are in compliance with provisions that have already gone into effect
- Ask questions of your commission, or Corporation program and grants officers

Fixed Amount Grants

- According to the Serve Act the amount must be "significantly less than the reasonable and necessary costs of administering the program supported by the grant; and
- based on an amount per individual enrolled in the program receiving the grant…"

Opportunities for 2010

Full-cost, Full-time Programs: \$13,000

Professional Corps Programs: \$2,000

Also full-time

Education Award Programs: \$800

Advantages of Fixed Amount Grants

- OMB Cost Principles do not apply
- No tracking or documentation of cost sharing is required
- Budgets are not required during the application process
- Limited, if any, financial reporting to the Corporation

Disadvantages

- Programs can only draw all of the funds awarded if all members enroll (EAP) or if all members enroll and complete service (Full-time and Professional Corps programs)
- Programs must still raise significant support to operate the program

What Requirements Still Apply?

- AmeriCorps members must receive a living allowance of at least \$11,800 and health benefits
- Member documentation related to eligibility and criminal background checks must be confirmed and maintained
- Member time-keeping systems must be in place to track member service hours
- Appropriate program management and supervision must be provided

What Requirements Still Apply?

- OMB Uniform Administrative Requirements must be followed
- Single Audits must be conducted (if Federal expenditures exceed \$500,000/year)

Additional Guidance

- CNCS will give priority in the selection process to existing programs that have demonstrated experience and capacity to track performance measures.
- Grantees must participate in any evaluation the Corporation conducts on this pilot.
- Grantees will be encouraged to apply for fixed amounts less than the maximum.

Calculating Funds to Draw

- May access up to 20% immediately as long as you don't draw more than earned by the end of the budget period
- Then draw based on enrollments (EAP) or enrollments and completion (Other fixed grants)
- For full-cost at \$13,000 for 10 members with 8 members earning awards and 2 completing 920 hours

```
-8 \times \$13,000 = \$104,000
-920/1700 \times \$13,000 = \$14,040
Total \$118,040
```

Social Innovation Fund

- Promote investment in effective and potentially transforming activities of non-profit community organizations and replicate and expand them to serve more low-income communities
- Identify effective approaches in addressing critical social challenges and share their knowledge
- Develop a robust grant-making infrastructure

Social Innovation Fund

- \$50 million available in 2010 for 7 -10 grants
- Eligible applicants are intermediaries Existing grant-making institutions or eligible partnerships
- Grantee match is more than \$1 for \$1
- Due Date for Applications: April 8, 2010

Priority Areas

- Economic Opportunity
- Youth Development and School Support
- Healthy Futures

Intermediaries will:

- Select subgrantees through a competitive process
- Support them with technical assistance and evaluation
- Monitor them and track their performance
- Assist them to replicate and expand to serve more individuals and/or communities

Volunteer Generation Fund

- Establish programs to recruit, manage and support volunteers in effective volunteer support structures in states; and
- Identify effective approaches to increasing volunteer opportunities and managing and supporting volunteers

Volunteer Generation Fund

- \$4 million available in 2010
- Eligible applicants: State commissions
- Minimum Grant: \$75,000
- Grantee match increases over four years from 20% to 50% for all succeeding years
- NOFA will be released: March 23, 2010
- Due date for applications: May 18, 2010

Nonprofit Capacity Building Program

- Deliver organizational development assistance to small and midsize nonprofits, especially in areas where nonprofit organizations face significant resource hardship challenges.
- Provide technical assistance in areas such as best practices, financial planning, grant-writing, and compliance on applicable tax laws.

Capacity Building Fund

- \$1 million available in 2010
- Eligible applicants: Intermediary Organizations
- Minimum Grant: \$200,000
- Grantee match is 50%
- NOFA will be released: Late March 2010
- Due date for applications: Late May 2010
