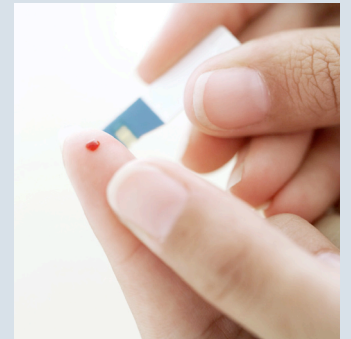

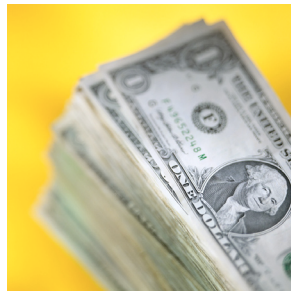
Medicare Helps Manage Diabetes

Medicare helps cover diabetes services and supplies, including:

- Diabetes self-management training
- Medical Nutrition Therapy
- Hemoglobin A1c tests
- Glucose monitors, test strips, lancets, insulin, some insulin pumps
- Glaucoma & other eye tests
- Foot exams & treatment, therapeutic shoes



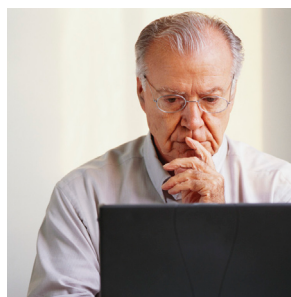

2010 Part B Monthly Premium

The 2010 standard Part B premium is \$110.50. However, most people will **still pay the 2009 amount of \$96.40** in 2010. People who have their Part B premium withheld from their Social Security benefits and have incomes of \$85,000 or less (or \$170,000 or less for joint filers) will not have an increase in their Part B premium for 2010. This is because there's no cost-of-living increase in Social Security benefits this year.

Now's the Time to Review Your Plan!

Medicare's Open Enrollment Period runs from November 15 to December 31. This is your chance to **review your current coverage** and make sure it meets your needs.

What You Should Know About SNF Care

Skilled Nursing Facility (SNF) Care Is Costly

SNF care can be expensive. You should know that Medicare will only cover care in a SNF for a limited period, and only after your loved one has been a hospital inpatient for 3 days in a row.



Medicare Requires 3 Hospital Inpatient Days

Days spent in outpatient status, like getting ER or observation services, don't count. The day of admission to inpatient care counts as the first day, but the day of discharge doesn't count.

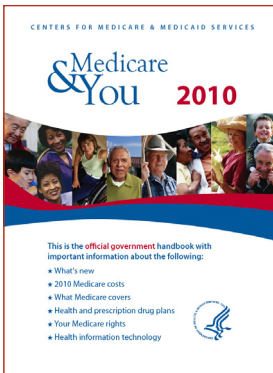
Ask your doctor if your loved one is an inpatient or an outpatient.

If your loved one doesn't have the 3-day inpatient hospital stay, ask if they can get care in other settings (like home health care) or if any other programs like Medicaid or Veterans' benefits can cover their SNF care.

Prevent Fraud — Check Your MSN

People with Medicare get a **Medicare Summary Notice (MSN)** every 3 months that shows all the supplies and services they got. You should always check the MSN to make sure your loved one got everything that's listed.
