# 15 FAM 630 MAINTENANCE, REPAIR, AND CUSTODIAL RESPONSIBILITIES

#### Changes

- 1. **15 FAM 165, Security Costs**: This revised section shows how security costs are allocated. Changes appear in *italic* and *dark magenta*. Italic and dark magenta provide an historical record of changes.
- 2. **15 FAM 180, Funding Guidelines**: This subchapter is new and codifies building maintenance expense (BME) as a function code. Therefore, revisions since the last update will not appear in *italic* and *dark magenta* in this issuance.
- 3. **15 FAM 636.1-2, Funding and Approval**: Department of State: Preventive maintenance contracts for generators supporting nonresidential facilities are considered a Building Maintenance Expense (see 15 FAM 182, 7904 Building Maintenance Expense, second text paragraph). Changes appear in *italic* and *dark magenta*.

- 4. **Change Transmittal** has replaced the term, Transmittal Letter. Change Transmittal was selected as being more appropriate in this age of electronic information transmission.
- 5. Officers are reminded that Department-issued materials not codified in the Foreign Affairs Manual or its supplemental Foreign Affairs Handbook series generally have no regulatory validity (see 2 FAM 1115.2).

#### Filing Instructions for Paper Copies

- Remove and discard old subchapter 15 FAM 160 (CT:OBO-2, 08-26-2005; 14 pages) and replace it with revised subchapter 15 FAM 160 (13 pages).
- Remove and discard old page 15 FAM 180 and 190 Unassigned (CT:OBO-1, 04-29-2005; 1 page) and replace it with new subchapter 15 FAM 180 and new page 15 FAM 190 Unassigned (6 pages total).
- 3. Remove and discard old subchapter 15 FAM 630 (CT:OBO-5, 03-21-2006; 9 pages) and replace it with revised subchapter 15 FAM 630 (9 pages).
- 4. After inserting the material in the binder, insert this change transmittal immediately following the CT (formerly TL) checklist, then fill in the entry line for CT:OBO-18, and initial.
