Use for reporting of CIP issues both as they

KCOG: Continuity of the Federal Government

KCOM: Chief of Mission

Effective March 2004 Action Office: Appropriate Bureau

Use for all documents addressed for action to the chief of a U.S. mission in a foreign location (e.g., ambassadors, chargés d'affaires, consuls general, or principal officers). Use KCOM in conjunction with generic PASS instructions to chiefs of mission in Department telegrams. Also use the appropriate Subject TAGS.

KCOR: Corruption and Anti-Corruption

Effective August 2001 Action Office: Appropriate Bureau

Use for all documents relating to corruption and anti-corruption, dishonesty, and unethical behavior among public officials representing local, provincial, and national governments. This would include linkages with justice, economic, social and political entities. Also use appropriate Subject TAGS.

KCRM: Criminal Activity

Effective April 1994; revised April 2000 Action Office: INL/ENT

Use on all documents relating to criminal organizations and activities, the threat they pose to U.S. interests and/or friendly governments, and host country and

R/S operations include the following sectors: transitional security, rule of law, governance and participation, economic reconstruction, humanitarian assistance, rebuilding of infrastructure, operations planning, and mission management. The United States (civilian or military), an international organization, a multilateral body, or a coalition can lead R/S operations. They are distinct from normal bilateral operations aimed at promoting economic and democratic development, due to an extraordinary international presence (proposed or actual) that assumes some authority normally exercised by a host government. Also use appropriate Subject TAGS.

KCSY: Consular Systems

Effective July 1995 Action Office: CA/EX/CSD

Use on all documents relating to the development, testing installation, and maintenance of consular automated systems. This includes computer hardware, software, and telecommunications (TC) lines when used in connection with consular systems applications. Use on communication sent for attention and/or action of the consular affairs support desk. Also use on documents concerned with consular systems management, consular systems training, consular systems security, or any other consular systems issues. Also use appropriate Subject TAGS.

The U.S. Government is devoting significant resources to monitor and promote regional trends away from autocratic rule and toward political pluralism. Programs designed to encourage democratization are diverse, and often are cross-discipline in nature, requiring the involvement of several U.S. Government agencies. Also use the appropriate Subject and Geo-Political TAGS.

KDIS: Persons with Disabilities and Disability Issues

Effective July 2011 Action Office: HR/EX

Use on all documents dealing with issues of disability, persons with disabilities, disability and human rights, disability access and disability inclusion. The U.S. government is committed to the inclusion of disability issues and persons with disabilities in U.S. foreign policy and programming. Also use appropriate Subject TAGS.

KDRG: Detainee Repatriation from Guantanamo Bay

Effective December 2007 Action Office: S/WCI

It is intended as a venue for sharing reform experiences, highlighting successes and obstacles and supporting countries committed to economic reform. Also use appropriate Subject TAGS.

KEMS: Electronic Messaging Systems

Effective March 1995 Action Office: Appropriate Bureau

Use on all documents relating to all phases of unclassified electronic messaging systems including: OpenNet and Internet. Also use appropriate Subject TAGS.

KESS: Emergency Security Supplemental

Effective February 1999 Action Office: Appropriate Bureau

Use on all documents dealing with Emergency Security Supplemental activities and approvals for security related project funds charged to the Emergency Security Supplemental appropriation. Also use appropriate Subject TAGS.

Use on all documents relating to trade controls imposed for foreign policy or short supply purposes, and to all proposals to initiate or terminate controls. This includes embargoes, sanctions, boycotts, assets controls, and other import and export controls not relating to high technology items and all strategic and dual use controls not relating to national security controls. KGIT: Global Information Technology Modernization Program

Effective October 2003 Action Office: IRM/OPS/ITI/GITM

Use for documents relating to all aspects of the Global Information Technology Modernization Program. This includes all discussions of system designs, local LANS and infrastructure, overseas virtualization, procurement and shipping of servers, workstations, printers, switches, and routers. This also covers all planning and dates for installation of servers, switches and routers, thin clients and workstations.

KGLB: Global Learning and Observations To Benefit the Environment—The GLOBE Program

Effective June 1994; revised April 2000 Action Office: OES/ENV

Use on all documents pertaining to Vice President Gore's initiative known as The GLOBE Program (now administered through NOAA). The program is designed to:

- Engage school teachers and children worldwide in environmental science, mathematics, and technology activities by conducting scientific experiments locally; and
- (2) Produce scientific data that will contribute to a greater understanding of the planet by scientists. Also use appropriate Subject TAGS.
