

TRICARE® and Cognitive Rehabilitation Therapy

Information for Providers and Beneficiaries

TRICARE incorporates cognitive rehabilitation services into rehabilitation benefits

When people talk about "cognitive rehabilitation therapy," they are actually not talking about one therapy—they are talking about a collection of rehabilitation techniques that may be used to help improve an individual's ability to function after a brain injury, including traumatic brain injury (TBI). In other words, it is not a single therapy.

TRICARE-covered cognitive rehabilitation services may be ordered by a physician as part of a comprehensive individual rehabilitation plan, including physical therapy, occupational therapy, and speech-language pathology services, provided to beneficiaries with TBI. TRICARE covers rehabilitative services provided by TRICARE-authorized physicians, psychologists, physical therapists, occupational therapists, and speech-language pathologists.

HOW ARE REHABILITATIVE SERVICES COVERED FOR SERVICE MEMBERS ON ACTIVE DUTY?

Service members on active duty (greater than 30 days) have full TRICARE benefits with no out-of-pocket costs. Covered services may be available for active duty service members with prior authorization from a military treatment facility (MTF), the Military Medical Support Office (MMSO) (remote locations), or TRICARE Area Offices (overseas). HOW ARE REHABILITATIVE SERVICES COVERED FOR RETIRED SERVICE MEMBERS?

Retired service members have the full comprehensive TRICARE retiree benefit. Services may be available from MTFs or covered under TRICARE from civilian providers and facilities. Retirees are also veterans and may find services through the Department of Veterans Affairs. For more information on the Department of Veterans Affairs, visit www.va.gov.

WHAT MAY NOT BE COVERED BY TRICARE?

TRICARE covers medical treatments that are proven safe and effective. Some cognitive rehabilitation services have not been fully proven as effective stand-alone therapy for TBI. An example of a therapy that is currently not covered is hippotherapy (also known as equine therapy). Some cognitive rehabilitation services may be individually covered based on both medical-necessity determination and prior authorization.

HOW ARE REHABILITATIVE SERVICES REIMBURSED BY TRICARE?

TRICARE-authorized providers who provide medically necessary and appropriate cognitive rehabilitation services as an element of their professional comprehensive treatment regimen for individuals with TBI are reimbursed using the TRICARE maximum-allowable charge methodology. For example, an occupational therapist may use training for memory or attention deficits as part of occupational therapy. The occupational therapy services would be covered by TRICARE.
