Mr. Abrams, Program Counsel, OPP, introduced and moderated the panel discussion on the delivery of legal services in rural areas. The panel members included Ed Marks, Executive Director, New Mexico Legal Aid (NMLA); Peggy Lee, Senior Staff Attorney, Southeastern Ohio Legal Services (SEOLS); Kathy Duncan, Director of Pro Bono, Legal Aid of NorthWest Texas (LANWT); and Ilene Jacobs, Director of Advocacy, Litigation and Training, California Rural Legal Assistance (CRLA).

Mr. Marks began the panel discussion by speaking about the opportunities and challenges of rural legal services delivery. Next, Ms. Jacobs described some of the housing work in California and the need for additional resources in rural areas to assist clients with housing issues. Ms. Duncan next spoke about the efforts of LANWT's pro bono program. Finally, Ms. Lee described some of her foreclosure defense work and anti-scam work in one of Ohio's most rural region. The panel members then answered Committee members' questions. Chairman Mikva thanked the panel members for their presentation.
