The following summarizes actions taken by, and presentations made to, the Committee:

Chairman Levi called the open session meeting to order.

Ms. Browne moved to approve the agenda. Father Pius seconded the motion.

Judge Ruiz presented SCLAID's recommendation that LSC request \$470 million for its

FY 2014 budget request to Congress. She cited the current economic crisis as contributing to the

need for increased funding and emphasized this recommendation was both realistic and

reasonable to cover the ever increasing cost of providing legal assistance. Judge Ruiz answered Committee members' questions.

Mr. Saunders presented NLADA's recommendation that LSC seek \$516.5 million for its FY 2014 budget request to Congress. Mr. Saunders answered Committee members' questions, and stated that the request could be higher, but given the financial environment, NLADA believed this number was appropriate.

Mr. Richardson provided a brief summary of the Economic Policy Institute's (EPI) letter. The letter detailed a study comparing current funding to funding from 1980 and found that per capita, LSC is funding programs at about one third of 1980 funding levels. Additionally, the 1980 allocation would equal \$794.5 million in 2010 dollars. The EPI's letter suggested a \$1,250,000,000 request.

The Committee discussed updating the grantee surveys on the impact of funding cuts. The Committee also briefly discussed the status of the 2013 appropriations, which is currently before the Senate.

There was no other business to consider

Ms. Browne moved to adjourn the meeting. Father Pius seconded the motion.

The motion passed by voice vote.
