Thanks to the leadership skills and expertise they acquire during their service, many veterans go on to start small businesses. Now, with thousands of American veterans returning from Iraq, Afghanistan, and elsewhere throughout the world, the federal government must provide the tools and the support for them to start and grow their businesses.

On April 26th, 2010, the President signed Executive Order 13450, establishing the Interagency Task Force on Veterans Small Business Development. The task force will coordinate federal efforts to increase and improve veteran small business development. This includes increasing access to capital, improving business development opportunities, and meeting Federal contracting goals for veteran-owned small businesses and service-disabled veteran-owned small businesses.

Specifically, the Executive Order asked the Task Force to focus on six areas:

- 1) Improving capital access and capacity of small business concerns owned and controlled by veterans and service-disabled veterans through loans, surety bonding and franchising;
- 2) Ensure achievement of the pre-established Federal contracting goals for small business concerns owned and controlled by veterans and service-disabled veterans through expanded mentor-protégé assistance and matching such small business concerns with contracting opportunities;
- 3) Increasing the integrity of certifications of status as a small business concern owned and controlled by a veteran or service-disabled veteran;
- 4) Reducing paperwork and administrative burdens on veterans in accessing business development and entrepreneurship opportunities;
- 5) Increasing and improving training and counseling services provided to small business concerns owned and controlled by veterans; and
- 6) Making other improvements relating to the support for veterans business development by the Federal Government

Small businesses create nearly two out of every three new jobs and employ half of all American workers. They are a part of who we are as a nation, and it is our duty and moral obligation to provide our veterans with the tools they need to start and grow their business and create jobs.

Working Groups and Final Recommendations

The Task Force will establish working groups to focus on the **six subjects** that fall underneath the President's Executive Order. **Each working group** will come up with **1-3 proposals** for the final recommendations and include **specific implementation plans**. Each team will be led by a member of the Task Force, another co-chair, including leading experts from agencies and the White House, and may include additional representatives from the agencies represented on the Task Force. All six working groups will look for opportunities to improve coordination of resources across and within agencies and will identify specific measureable outcomes to which agencies can be held accountable. The Task Force will work between the kick off meeting and the first public meeting to appoint co-chairs to each working group.
